## Participant *Billing* FAQ's

### How do I register for my tour?

You can register for your tour online or by mail.

To register online, you will need the **Registration Code** found at the top of the attached Trip Information and Registration Form. Visit our website at [gerbertours.com](http://gerbertours.com), click on "**LOGIN/REGISTER**" located at the top of our website and then select "**PARTICIPANTS**" and follow the simple steps.

To register by mail, please complete and sign the attached Trip Information and Registration Form. Send it along with your initial deposit (payable by check or money order only) to the address located at the bottom of this flyer. Please be sure to include the participant's name and **Tour ID** on the check or money order. The **Tour ID** is located on the top of the Registration Form.

### How is my registration confirmed?

Your registration will be confirmed and secured once your initial non-refundable deposit has been received.

If you have registered online, you will receive a payment confirmation email along with an attached account statement, which includes your group's payment schedule.

If you have registered by mail, we will send you an account statement and a set of payment coupons to be used for making your remaining payments.

### How are remaining payments scheduled?

After you receive your account statement, the remaining balance may be paid in full by the next payment due date, or you may take advantage of our convenient installment plan. Installment payments carry a nominal \$5 non-refundable handling charge (initial deposits and final payments do not incur handling charges). There is a \$25 charge for late payments and returned checks. **Please note: checks and money orders should be made payable and sent directly to Gerber Tours, Inc.**

### How are cancellations and refunds handled with *Participant Billing*?

All cancellation notices and refunds must be submitted in writing to Gerber Tours at the address located at the bottom of this flyer or by email to [support@gerbertours.com](mailto:support@gerbertours.com) by the participant or (if under 18) the participant's parent/legal guardian no later than the tour departure date. Refunds are issued directly to the participant or the participant's parent/legal guardian, according to the Cancellation Policy located in the Terms and Conditions presented at the time of registration.

### How is fundraising money applied to my tour?

If you are receiving fundraising money from your school or organization to be applied to your account, please continue to make the scheduled payments and deduct the amount you anticipate receiving in fundraising from your final payment only.

### What if I miss the deadline for registration?

Late registrations are welcome provided there is still space available on the tour. You will need to bring your account balance up to date in accordance with your group's payment schedule at the time of your registration.

# TERMS & CONDITIONS, RELEASE OF LIABILITY AND ARBITRATION AGREEMENT

The following Terms and Conditions are applicable to your trip. "Gerber" is defined in this Agreement to include Gerber Tours, Inc., your school, association, organization or sponsor, and chaperones if applicable, and its and their employees, shareholders, subsidiaries, affiliates, officers, directors, successors and assigns.

**Tour Price:** Tour Price is based upon the features of your tour and a minimum number of travelers. A change in the tour features or number of Tour Participants may cause the Tour Price to increase, and therefore the payment schedule to change. In addition, an increase in supplier costs (e.g. fuel or energy surcharges, tax increases, etc.) may cause the Tour Price, and therefore the payment schedule to change.

**Deposits and Payments:** Your completed Registration Form and initial, non-refundable booking deposit are due by the date indicated on the Registration Form. After registering you will receive an invoice detailing your payment options. You may pay the remaining balance in full or you may take advantage of our installment plan. All installment payments carry a \$5 non-refundable handling charge except for the initial deposit and final payment. There is a \$25 charge for late payments and returned checks. However, your registration is subject to cancellation without refund if any payment is not received when due.

**Cancellations and Refunds:** All cancellation notices and requests for refunds must be in writing and mailed to Gerber Tours, Inc., 100 Crossways Park Dr West, Ste400, Woodbury, New York 11797-2012 postmarked, or emailed to support@gerbertours.com no later than your departure date. Refunds take apx. 4-6 weeks to process.

**Cancellation Protection (CP).** This optional, highly valued program assures a refund in case you need to cancel participation on the tour for almost any reason up until the day of departure. The program is only available at the time of Registration and entitles you to a refund of all monies paid toward the Tour, minus the cost of the CP, the non-refundable booking deposit, installment fees and any applicable returned check and/or late payment fees. Enrollment in the CP is not available within 60 days of departure. If you choose not to participate in this Program by filling in the "No" circle on your Registration Form, you are subject to the standard cancellation and may lose up to 100% of monies paid. CP cost is in addition to the Tour Price and will be included in your invoice amount. Refunds under the program are not available in the unlikely event your trip is cancelled or in the event of acts of government, epidemics, force majeure events or acts of terrorism.

**Standard Cancellation Policy.** If you choose not to enroll in the CP cancellation fees will apply. If your cancellation notice to Gerber Tours, Inc. is postmarked or emailed prior to 74 days of departure a fee of 20% of the Tour Price will apply; cancellation notice postmarked or emailed 45-74 days prior to departure, a fee of 50% of the Tour Price will apply and cancellation notice postmarked or emailed 44 -15 days prior to departure a fee of 75% of the Tour Price will apply. In all cases any non-refundable fees such as installment fees, returned check and/or late payment fees will be added. If cancellation occurs 14 days or less prior to departure no refund will be given.

**Health Proxy Forms and Medical Matters:** You must submit to your Tour Organizer a complete and accurate Health History and Medical proxy. Any medical or physical conditions that chaperones should know or that may interfere with your participation on the Tour or with others on the tour must be stated on your Form. I authorize the adults on my tour to obtain emergency treatment as deemed necessary by medical professionals. I understand that I am solely responsible for my pre-program, program and post-program medical care in all respects, including, but not limited to, obtaining and taking necessary medication(s), vaccinations and any other medical care and treatment. I certify that I will consult a physician qualified in travel medicine, immunizations and infectious/tropical diseases prior to my trip departure. Gerber may attempt to bring a participant to a medical facility for emergency treatment, but it is not responsible for any negligent or unsuccessful treatment thereat.

**Insurance:** Primary medical insurance is included for accident (\$5,000), illness (\$1,000) or accident related dental injury (\$500) that occur during travel. Pre-existing conditions are not covered and other terms apply. Please see [www.gerbertraveltours.com/groupins/coi.pdf](http://www.gerbertraveltours.com/groupins/coi.pdf) for complete details of coverages.

**Behavior:** Participants are responsible for exercising sound judgment, caution and respect for people, places and things while on tour and are expected to adhere to all rules and regulations set forth by Gerber and/or the Tour Organizer. Failure to do so, may result in the participant being sent home at own expense with no refund.

**Alcohol/Drug Policy:** Gerber has a zero tolerance rule for possession or drinking of alcohol for any participants under 21 and/or possession or use of any illegal drug or drug paraphernalia by any participant. Any participant violating this rule is subject to immediate expulsion from the trip. In any such case, the student or his or her parent or guardian is responsible for transporting the participant home, and waives any claim for any refund of any portion of the trip cost.

**Binding Arbitration:** I agree that any dispute concerning, relating or referring to this Agreement, the brochure or any other literature concerning my trip, or the trip itself, shall be resolved exclusively by binding arbitration pursuant to the Federal Arbitration Act, 9 U.S.C. §§1-16, either according to the then existing Commercial Rules of the American Arbitration Association (AAA) or pursuant to the Comprehensive Arbitration Rules & Procedures of the Judicial Arbitration and Mediation Services, Inc. (JAMS). Such proceedings will be governed by substantive (but not procedural) New York law and will take place in Mineola, NY. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable. Please understand that by agreeing to these terms and conditions, you (and we) are waiving our right to a trial by jury.

**Cancellations due to Governmental Action or Impossibility of Performance:** In the event a trip is cancelled or postponed due to the actions of any governmental or civil authority, school or school district, or a cancellation is caused for any other reason beyond the control of Gerber Tours, Inc., tour participants will be entitled to a refund of monies paid less non-recoverable expenses prepaid or incurred by Gerber Tours, Inc. and the non-refundable booking deposit.

**Responsibility Clause:** Gerber does not own, operate or control any person or entity which is to or does provide goods or services for your trip including, for example, lodging facilities, airline, vessel or other transportation companies, guides or guide services, local ground operators, entertainment or sightseeing operators, providers or organizers of optional excursions, food service providers, etc. All such persons and entities are independent contractors. As a result, Gerber is not liable for any negligent or willful act or failure to act of any such person or entity, or of any other third party.

Without limitation, Gerber is not responsible for any injury, loss, or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services resulting from, but not limited to, acts of government, acts of force majeure, war, civil unrest, insurrection, strikes or other labor activities, criminal conduct, threatened or actual terrorist activities, lost or stolen belongings, overbooking or downgrading of accommodations, mechanical or other failure of airplanes or other means of transportation or for any failure of any transportation mechanism to arrive or depart timely or safely, vehicular incidents, dangers associated with or bites from animals, pests or insects, sanitation problems, food poisoning, lack of or quality of medical care, illness or disease, epidemics or the threat thereof, difficulty in evacuation in case of a medical or other emergency, or for any other cause beyond the direct control of Gerber.

Changes in hotel or itinerary may be made at the discretion of Gerber or your local ground operator as it or they deem necessary or desirable. Trip participants are solely responsible for securing their own passports, visas, medical inoculations, reviewing State Department and other advisories or warnings, etc.

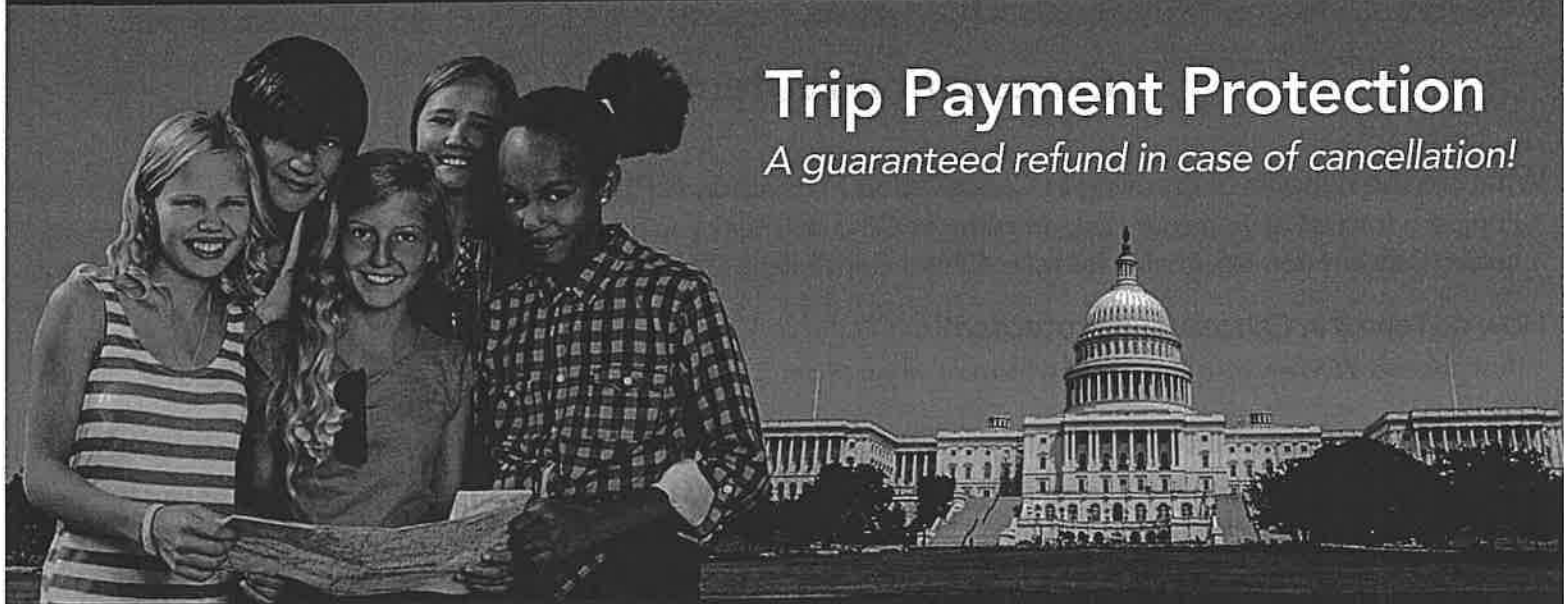

### How do I enroll in **Cancellation Protection**?

### I've enrolled in **Cancellation Protection** and need to cancel my tour, how should I apply for my refund?

- If you are certain that you have to cancel your trip, your first step is to notify both your Tour Organizer and Gerber Tours as soon as possible. All cancellation notices and requests for refunds must be submitted in writing to Gerber Tours by the participant or the participant's parent/legal guardian no later than the tour departure date. All correspondence should be emailed to support@gerbertours.com or mailed to our office using the address located below. Please include the Participant's Name, Group Name and tour departure date. A refund will not be issued if notification occurs after the tour departure date.

### I've enrolled in **Cancellation Protection** and need to cancel my tour, what will my refund include?

- If an unexpected situation causes you to cancel your tour, **CP** guarantees you a refund of your trip payments (less any non-refundable items\*). Refunds will be based on the total amount received by Gerber Tours for the Participant at the time of cancellation (less any non-refundable items\*).

### What if I **do not** enroll in **Cancellation Protection** but find that I need to cancel my tour?

- If you do not enroll in **CP**, the Standard Cancellation Policy will apply, and you may lose up to 100% of your payments. Please see Terms and Conditions on the back of the Registration Form for the Standard Cancellation Policy.

### Is there anything else I should know about **Cancellation Protection**?
